Andrea Carlevaris

Andrea Carlevaris became Secretary General of the ICC International Court of Arbitration in September 2012. Mr Carlevaris is also Director of the ICC Dispute Resolution Services.

Before joining ICC, Mr Carlevaris was a partner in the Rome office of Bonelli Erede Pappalardo. His practice covered international arbitration, judicial proceedings involving issues of public international law, conflicts of law and international civil procedure. Mr Carlevaris joined Bonelli Erede Pappalardo in 2003 and

became partner in 2010.

Prior to Bonelli Erede Pappalardo, Mr Carlevaris was counsel at the Secretariat of the ICC International Court of Arbitration, a member of the ICC International Court of Arbitration and of the ICC Commission on Arbitration.

Mr Carlevaris is a member of the Steering Committee of the International Arbitration Commission of the Union international des Avocat (UIA) and of the Board of Directors of the Italian Association for Arbitration (AIA). He is one of the founders of the Italian Forum on International Arbitration and ADR (ArbIt).

Mr Carlevaris graduated magna cum laude from the University of Rome (La Sapienza), where he received a doctorate in international law in 1999. The same year Mr Carlevaris was admitted to the Italian Bar.

Mr Carlevaris is the author of a monograph on conservatory and provisional measures in international arbitration and of numerous articles. He regularly contributes to several journals, including the Rivista dell'arbitrato, serving on the journal's editorial board. In 2011, Global Arbitration Review named him one of the most prominent international arbitration lawyers under the age of 45 ("45 under 45").

José Ricardo Feris is the Deputy Secretary General of the ICC International Court of Arbitration in Paris, France. His experience in international dispute resolution includes being a law clerk to Judges Rezek and Kooijmans at the International Court of Justice in The Hague. He also worked for the Legal Advisor to the President of the Dominican Republic and represented the Dominican Republic before the Free Trade Agreement of the Americas' negotiation rounds.

In 2006 he was recognized by Junior Chamber International as "Outstanding Young Dominican." He has also been identified by Latin Lawyer as one of the most noteworthy arbitration careers of the Latin American diaspora. He is a founding member and currently serves as board member and Co-Chair of the Editorial Committee of the Latin American Arbitration Association (ALArb). In addition to Spanish, his native language, he speaks English, French and Portuguese.
