Project Description

The RESUME project aims at enhancing and reinforcing the role and potential of HEIs in the development of employability in the Mediterranean countries by adopting a transversal entrepreneurial mind-set at the Higher Education Institutions and by opening and structuring the dialogue among the universities, the enterprises and the policy makers.

Tender Specifications

Currency of the tender: tenders shall be presented in EURO for both the unit prices and the overall amount of the commitment. The currency of payment will be also in EURO.

Language of the tender: tenders shall be presented in English.

The tenderer must provide and complete the following documents:

1. Tender duly signed, dated and sealed; including:

- Profile of the company
- Main contact's name, phone number, email and address
- Completed bill of quantities for the selected section(s) with unit and total price excluding VAT
- Technical specifications
- Catalogs of the proposed equipment

2. A photocopy of the trade name registration papers

3. Signed letter for after-sales service and 12-month warranty letter

Additional documents such as instructions and operating manuals shall be required with the delivery of equipment.

The payment shall be done according to the following terms:

- 30% upon signature of the contract
- 50% upon delivery of the equipment
- 20% after 30 days of delivery of equipment

The delivery period may not exceed 30 days from the date of signature of the contract with the selected supplier.

The award method will be the "best value for money" meaning that the winning tender is the one offering the best quality/price ratio.
